ICE used the following criteria to determine which students receive Emergency Financial Aid Grants under the ARP (a)(4) program, prioritizing students with exceptional need:

- Must be actively enrolled or on an approved leave of absence as of February 1, 2022;
- Must have a 2021-2022 or 2020-2021 Free Application for Federal Student Aid (“FAFSA”) on file;
- Must have an Expected Family Contribution (“EFC”) as determined by the FAFSA as outlined in the chart below:

Expected Family Contribution	Amount of Grant
\$0 - \$5,500	\$1,100
\$5,501 - \$9,999	\$ 950
\$10,000 - \$15,000	\$ 900

The 2021 - 2022 FAFSA EFC will be used to determine the amount of the HEERF III Grant; if only a 2020 - 2021 FAFSA is on file, the 2020 - 2021 EFC will be used.

7. Any instructions, directions or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Students received an email informing them that ICE had received ARP (a)(4) funds and would distribute automatic grants in the amount of \$1,100, \$950 or \$900. The email also contained the following instructions:

Please note that grants may be used for “any component of the student’s cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.”
